The Stewards, having received a report from the FIA Technical Delegate (Annex 1 to the Initial Scrutineering Report – Update) have considered the following matter, determine the following:

Driver and car No: Parcidio SUMMAVIELLE, 44

Competitor: Parcidio Summavielle

Time (fact): 18:10h, Initial Scrutineering

Fact: During the Initial Scrutineering a difference in Performance factor number with respect to the Pf Technical sheet was found. By recalculating the Pf number results, does change the classification group from 5 to 4.

Offence: Breach of Article 6.7.6 of the FIA EHC General Prescriptions, Art. 9 EHC Sporting Regulations – Category 1.

Decision: Warning penalty imposed in accordance with the Art 21.1.15 EHC Sporting Regulations – Category 1.

(First time infringement during the season)

Reason: Having considered the matter extensively, the Stewards determined that submitting a car to scrutineering shall be considered as an implicit statement of conformity. If an error or incorrect data concerning the Pf is discovered during initial scrutineering, the error must be corrected on the Pf Technical Sheet in order to simulate and check the car's new Pf number.

If the new Pf obtained classifies the car in a different group to the one in which the Competitor is entered, the non-conformity of the Pf Technical Sheet will be reported to the Stewards and a penalty must be applied (Articles 15.3.1 & 15.3.3 EHC Sporting Regulations – Category 1).

Only one group change per season, during a Competition, following an error or incorrect data is accepted. The penalty for breaching this rule in the future will result in a 10-point penalty per breach, to be deducted from the total number of points scored in overall classification and the FIA Championship group classification. The penalty applies to any breach before the first "starting order" list is published, as per Art. 15.3.4 EHC Sporting Regulations – Category 1.



The Competitor is reminded that he has the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
