The Stewards, having received a report from the FIA TD (Annex 1 to the Technical Delegate Report – After R1), that on the car No 42, the measurement results out of the tolerance (Art. 21-14 of the Sporting Regulation), have considered the following matter, determine the following:

Driver and car No: Maciej SERAFIN, 42

Competitor: Maciej SERAFIN

Time (fact): 11:30

Session: Scrutineering after R1

Fact: The maximum engine speed measurement was out of tolerance (Art.21-14 of the Sporting Regulation). Simulating the new performance factor, it does not change the Group (pf Group 4).

Offence: Breach of Articles Art.258-1-16.5.20 of the Appendix J and Art. 21-14 of the Sporting Regulations.

Decision: A fine of 250 € **which is suspended until the end of the season 2023**, subject to no further breach of a non-conformity with the Pf Technical data (outside of tolerances but without changing of group), observed during the scrutineering under Pf regulations (at any time after the publication of the first "Starting order list"), is imposed in accordance with Article 21.1.14 EHC Sporting Regulations – Category 1).

First time infringement during the season.




Reason: Having considered the matter extensively, the Stewards determined that the

The regulations clearly states that **a suspended penalty will be applied for this infringement, not enforceable at first occurrence (only from the second occurrence onwards of the same infringement).**

In case of a second infringement, during the 2023 season, the competitor will pay this first fine, in addition to the sanction that correspond for the second infraction. The penalty applies to any breach after the first "starting order" list is published, as per Art. 21.1.14 EHC Sporting Regulations – Category 1.



The Competitor is reminded that he has the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
