The Stewards, having received the report from the FIA Technical delegate (doc. No. 4.3) and after inspecting the situation, issued a Decision, determined the following:

**Driver and car No:** Christian FERSTL #19

**Competitor:** MSC Rottenegg

**Time (fact):** 13:00 hrs

**Session:** After Practice 1

**Fact:** During the scrutineering after 1<sup>st</sup> Practice heat, The ride height of car was measured after Practice 1 and found to be lower than the minimum value mandated by Appendix J, article 258-2-5.7 (bodywork facing the ground), resulting in a non-compliance.

**Offence:** Breach of art. 258-2-5.7 of the Appendix J.

**Decision:** Deletion of a Driver's practice time according 12.4.1e ISC FIA

**A fine of 250€ which is suspended until the end of the 2025 season**, subject to do not further breach of a non-conformity with the PF technical data (outside of tolerance but without changing of group), observed during scrutineering under PF regulations (at any time after the publication of the first "starting order list"), is imposed in accordance with Article 21.1.14 EHC Sporting Regulations – Category 2. It is first time infringement during the season. The competitor is excluded from the results, according to the ISC art. 12.4.1e.

**Reason:** Having considered the matter extensively, the Stewards determined that measurement has been carried out complying with the regulations and at no time during the Competition may the car measurements be out of tolerance reported in the PF Technical sheet entered in the Competition and comply with the tolerance established by the technical regulations

The Competitor is reminded of his right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
