The Stewards, having received the report from the FIA Technical delegate (doc. No. 4.2 Annex 1 to Post-initial Scrutineering) and after inspecting the situation, issued a Decision, determined the following:

Driver and car No: **Krzysztof CZAJA 46**

Competitor: Krzysztof Czaja

Time (fact): 17.00 hrs

Session: During the initial scrutineering

Fact: During the initial scrutineering a difference in Performance Factor number with respect to the Pf Technical sheet was found. By recalculating the Pf number results, does change the classification group from 4 to 3.




Offence: Breach of Article 6.7.6 of the FIA EHC General Prescriptions, Art. 9 EHC Sporting Regulation — Category 1.

Decision: **Warning penalty** imposed in accordance with the Article 21.1.15 EHC Sporting Regulations — Category I. First time infringement during season.

Reason: According to the regulations (Art. 15 of Sporting regulations of the FIA European hill climb championship - category 1) to any breach before the first Starting Order List if an error or incorrect data is discovered during the Scrutineering, the error must be corrected on the Pf Technical Sheet to create the car's new Pf number. If the new Pf obtained classifies the car in a different group to the one in which the Competitor entered, the non-conformity of the Pf Technical Sheet will be reported to the Stewards. Only one group change per season following an error or incorrect data is accepted.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits (both documents can be found at <https://www.fia.com>).
