The Stewards, having received the oral report from the FIA Safety Delegate and written reports from the Marshals from Marshal Post 20 and 21 and having examined the situation and heard the competitors/drivers (Summons 3, Doc No 2.9, Fausto Bormolini / Fausto Bormolini #6 and Summons 4, Doc. No 2.10, RS Sport / Christian Broberg, #7), have issued a Decision (Doc. No 2.11), determined the following:

Driver and car No: Fausto BORMOLINI, No 6

Competitor: Fausto Bormolini

Time (fact): 11:30

Session: the First Heat

Fact: disrespect of the red flag exposed due to the incident with car #8 at Marshal post 22

Offence: Breach of Art. 16.1 of Sporting Regulations of the FIA European Hillclimb Championship,




Breach of Art 21.1.7 failure to respect instructions given by the flag signals, infringement of the Drivers' Briefing given by the CoC

Decision: Disqualification from the race


Reason: The Stewards have examined the matter extensively, have heard Competitor #7 who reported he had immediately stopped after seeing the exposed red flag at Marshal Post 20. Approximately 30 seconds after he had been stopped, Competitor #6 hit his car. At the same time, Competitor #6 said he did not see any red flags apart from the one on Post 22 (which was waved at the place where the original incident had happened). Taking into consideration the report from the Marshal from the MP20, where he said Competitor #6 did not respect the exposed red flag and continued racing until he crashed into the car of Competitor #7 who was stopped after MP21, the Stewards decide to disqualify Competitor #6 from the race because of disrespect of Marshals' instructions and dangerous behaviour during the Heat.


Following this Decision, the Competitor is removed from the Classification and all the other competitors move up the ranking.

The Competitor is reminded that he has the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
