The Stewards, having received the report from the FIA Technical delegate (Annex 1: Post-Initial Scrutineering Pf value modification), and after inspecting the situation, issued a Decision determining the following:

Driver and car No: Joseba IRAOLA LANZAGORTA, #1

Competitor: Euskadi Automovilismo Enak Kluba

Time (fact): 19:20

Session: Initial Scrutineering

Fact: The PF value, as determined during scrutineering, differs from the technical sheet. By recalculating the Pf number, the result changes the classification Group¹ to Group².

Offence: Breach of art. 15.3.4 of the FIA EHC Sporting Regulations for 2026.

Decision: A warning (the first infringement of the season) in accordance with Art. 15.3.4 of the Sporting Regulations of the FIA EHC 2026 and in accordance with Art. 21.1.15 of the Sporting Regulations of the FIA EHC 2026.

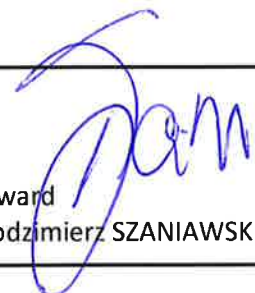
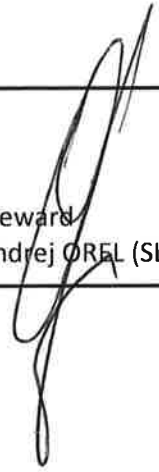
Reason: According to the regulations (Art. 15.3.1) to any breach before the first Starting order list if an error or incorrect data is discovered during the Scrutineering, the error must be corrected on the PF Technical Sheet in order to create the car's new Pf number.

If the new Pf obtained classifies the car in a different group to the one in which the Competitor is entered, the non-conformity of the Pf Technical Sheet will be reported to the Stewards.

Only one group change per season following an error or incorrect data is accepted. Therefore, taking into consideration that it's the first infringement of the driver, a Warning is imposed, and no Penalty points will be deducted in this case.



The Competitor is reminded of his right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 5 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
