The Stewards, having received the report from the FIA Technical delegate (doc. No. Annex 1: Technical regulation non-conformities identified after R2), summoned the driver by CRO and heard the driver, have considered the following matter and issued a Decision determining the following:

After Race 2

Fact:

Following Race 2, the rear axle width of Car #81 (Jiří THEIMER) was verified and found to be outside the allowed tolerances with respect to the value declared in the PF Technical Sheet. Regulation Breached: Article 258-1.16.7.9 of Appendix J.

The PF Technical Sheet specifies a width of 1840 mm (tolerance is +/- 20mm), whereas the car was measured at 1885 mm upon arrival at the finish line.

A recalculation of the Performance Factor using the actual width of 1885 mm was performed. This adjustment results in a change to the assigned Group (from Group 3 to Group 2).

Breach of art. 258-1.16.7.9 of Appendix J

Decision:

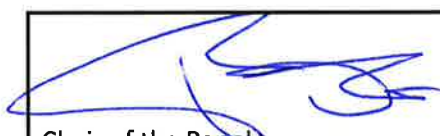
Disqualification from Race heat 2

Reason:

During the hearing the driver confirmed that the dimension checked by the FIA Technical Delegate was 1885 mm and that competitor representative Mr Vlastimil Malik is not present in Ilirska Bistrica. Having considered the matter extensively, the Stewards determined that the measured Performance factor does not comply with the value of the declared in the PF technical Sheet and issued the decision to disqualify #81 from Race heat 2.



The Competitor is reminded of his right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 5 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
